Tender Notice

Sealed tenders in 2 (two) envelope system are hereby invited by Bangladesh Services Limited for supply, installation, testing, commissioning and balancing of 1 (one) passenger elevator at 5-storied building No. 3 of BSL Office Complex, 1 Minto road, Dhaka-1000 from reputed, bonafide and eligible firms/ manufacturers/suppliers experienced in such works. The work is to be completed without interrupting the normal operation of the complex.

2. The intending tenderer should fulfill the following minimum qualifications and requirements for their participation in the said tender:
 - (a) Should have experience in supply, installation, testing, commissioning and balancing of the higher capacity passenger elevators with not less than 5 stops, which has been successfully completed during the last 5 (five) years (certificates(s) from the employer(s) of the completed projects are to be furnished) and should have facilities in Bangladesh for all after-sales services.
 - (b) Should have valid agency ship/dealership from the elevator manufacturer.
 - (c) Must ensure availability of spare parts of the Elevator to be supplied and installed from the manufacturer for a period of 15 (fifteen) years from the date of expiry of maintenance period.
 - (d) Possess documentary proof of bank solvency certificate.
 - (e) Should have valid trade licence, income tax clearance certificate for the financial year 2019-2020 and TIN No. and VAT registration certificate.
 - (f) Should possess valid ABC contractory and supervisory electrical license (photocopy of licenses to be furnished).
3. The intending tenderer shall submit an application to the undersigned stating their eligibility for obtaining Tender Documents. Tender documents will be available in the office of the undersigned during office hours from **16/01/2022** to **31/01/2022** on payment of Tk.5,000 (Taka five thousand only) (non-refundable) in cash to BSL.
4. Earnest money amounting to Tk.1,50,000.00 (Taka one lac fifty thousand) in the form of Bank Draft/Pay order from any schedule bank of Bangladesh located in Dhaka issued in favour of Bangladesh Services Limited shall have to be furnished along with the Tender Document without which the Tender shall be rejected outright.
5. The Technical Proposal and Financial Offer submitted separately in sealed envelopes will be received in the office of the undersigned, upto **12:00** noon on **07/02/2022** and Technical Proposals will be opened at **12:30 PM** on the same day at the same place in presence of the tenderers' representatives who may like to remain present.
6. Bangladesh Services Limited reserves the right to accept any tender or reject any or all the tender and increase or decrease the quantity of work, without assigning any reason whatsoever.
