  - (f) Should possess valid ABC contractory and supervisory electrical license (photocopy of licenses to be furnished).
- 3. The intending tenderer shall submit an application to the undersigned stating their eligibility for obtaining Tender Documents. Tender documents will be available in the office of the undersigned during office hours from 16/01/2022 to 31/01/2022 on payment of Tk.5,000 (Taka five thousand only) (non-refundable) in cash to BSL.

Earnest money amounting to Tk.1,50,000.00 (Taka one lac fifty thousand) in the form of Bank Draft/Pay order from any schedule bank of Bangladesh located in Dhaka issued in favour of Bangladesh Services Limited shall have to be furnished along with the Tender Document without which the Tender shall be rejected outright.
