

Terms & Conditions

1. All Tenders must be accompanied by earnest money, which is 10% of the total quoted amount, without which the Tender shall be rejected instantly.
2. Particulars of the auction including Terms and Conditions (Schedule) may be obtained from the Office of the undersigned on payment of Tk.5,000.00 (Taka five thousand only) in cash (nonrefundable) during Office hours from 07/05/2023 to 28/05/2023.
3. **Submission of Tender**
 - 3.1 Tenders are to be submitted in soft copy by email as noted below and also in hard copy. Tenders are to be submitted in separate emails Tender Document including Financial Offer and Password Code.
 - 3.2 Earnest money amounting to 10% (ten percent) of the total quoted amount in the form of bank draft/pay order from any scheduled bank of Bangladesh located at Dhaka in favour of Bangladesh Services Limited shall be furnished along with the Tender **without which your tender shall be rejected outright.**
 - 3.3 Bidders have to submit their scan copy of the Tender document including Financial Offer, Earnest money, Money receipt for purchasing of the Tender document, Trade licence electronically in an '**Encrypted**' PDF format to the following email address bid.bsl@intercontinental-dhaka.com. Tenderers encrypted email **MUST** reach to Bangladesh Services Limited on or before **2.00 PM** (Bangladesh Standard Time) of **30/05/2023**. Tenders not received by this time and date will not be accepted for any reason whatsoever.
 - 3.4 The **Password Code** to unlock the 'encrypted' PDF Tender Document including Financial Offer must be e-mailed separately to bid.bsl@intercontinental-dhaka.com between **2:00 PM to 3:00 PM** (Bangladesh Standard Time) of **30/05/2023**, further action and review.
 - 3.5 If the submission documents file sizes are more than 8MB, please send the soft copy of the submission document to bid.bsl@intercontinental-dhaka.com through mailmassive/dropbox/hightail/wetransfer or similar and forward the link email as acknowledgement prior to closing time.
 - 3.6 In addition to the above soft copy submission, the hardcopy of the Tender Document including Financial Offer, Original pay order/Bank draft for Earnest money, Original Money receipt for purchasing of the Tender document, photocopy of trade licence by post/courier must be submitted in sealed envelope **within 24 hours** after the closing time i.e. **2:00 PM** of **31/05/2023** and the tenders shall be opened at 3:00 PM same day at same place in presence of the bidders in any.



- 3.7 The sealed envelope is to be marked "Auction sale of 8(eight) Nos. old vehicles "As it is where it is" basis and removal of these from InterContinental Dhaka Premises at 1 Minto Road, Dhaka-1000".
- 3.8 The envelope is to be clearly marked with the name, address, and contract number of the bidder.
