 - c. Should own equipment like Gondola or hanging type bamboo and rope made scaffolding, conventional scaffolding etc. safety net and other safety equipment to complete the work in all respect without interrupting the day to day activities of the complex.
 - d) Possess documentary proof of bank solvency certificate.
 - e) Possesses documentary proof to the effect that their annual turnover is not less than Tk.4.00 crore.
 - f) Should have valid trade licence, income tax clearance certificate for the financial year 2019-2020 and TIN No. and VAT registration certificate.
- 3. The intending firms/paint manufacturers while submitting application for purchase of Tender Documents will furnish a declaration on non-judicial stamp to the effect that they fulfill the eligibility criteria. Tender documents will be available in the office of the undersigned during the office hour from 12/10/2021 to 02/11/2021 on payment of Tk.5,000 (Taka five thousand only) (non-refundable) in cash to BSL.
- 4. Earnest money amounting to Tk.3,00,000.00 in the form of Bank Draft/Pay order from any schedule bank of Bangladesh located in Dhaka issued in favour of Bangladesh Services Limited shall have to be furnished along with the Tender Document without which the Tender shall be rejected outright.
- 5. The Technical Proposal and Financial Offer shall have to be submitted separately in sealed envelopes, which will be received in the office of the undersigned up to 12:00 noon of 09/11/2021 and the Technical Proposal will be opened at 12:30 PM on the same day at the same place in presence of the tenderers (if any). Financial Offers of only those firms will be opened, who would qualify in the evaluation of their Technical Proposal.
